April's Monthly Spotlight: Please join our monthly webinar highlighting the SBRC Gradebook Roll-Up. Our specialist Jennifer Dominguez will give an overview of an eSD feature that assigns selected standards to assignments. These scores then "roll-up" to assist with the standards rubric on the Learning Standards tab within Teacher Connect.

Operoo Overview: A special presentation by representatives from Operoo. From registration and onboarding, to online forms and approval workflow (and more), Operoo is a service that integrates with Student Management Systems to help streamline and automate processes that schools routinely perform. Operoo provides a simple way for parents/guardians to sign forms, make payments and safely share emergency and medical data with schools and clubs.

Updates:

eSD 10.7 – coming soon: With the newest version, you can adjust your notifications in zaps to receive emails only if the zap fails; a new GURU profile is being introduced for "Student Medical Condition(s)"; state reporting for students with entry code 8300 will automatically export with location code of 0000 by default without additional adjustments; and the study hall wizard issues with partial scheduled courses has been corrected.

Reminders:



Attendance: If your district adds any additional attendance reasons, please make sure to notify our team (<u>eschooldatateam@e1b.org</u>) so we can make sure these reasons are being mapped correctly to the state.



Grade Reporters: Make sure that you are re-running marking period totals at the end of each marking period for every marking period up to the current one. This will help to catch any grades updated in the system that may have changed due to medical or other reasons.



Registrars: The "Undo Transfer" button should only be utilized when the student never actually left the building. If a student leaves and returns, do not use this "undo transfer" to ensure accurate enrollment history. Also – please *never delete the current enrollment line!*



Schedulers: Remember to uncheck the box for "offered course" in the 2023-24 school year for any courses you would like to keep in the database but don't plan to utilize it next year. This will prevent any accidental course requests for these courses.



Summer School: If your district is hosting summer this school, please make sure to fill out the <u>Summer School</u> <u>Setup</u> Form. There are options to complete the form online, or to download a form and upload your responses.

School Setup 2023-2024 School Year: If you have not already done so, please complete the 2023-24 School Setup Form for next year for all buildings that courses will be setup in. You do not need to have start/ending dates yet or specific bell times. As soon as the school setup is done, you may begin scheduling for next year. Thank you for your cooperation!
